How to complete your booth application

- 1. Complete your booth application August 1–26 to receive a scheduled appointment during Onsite Sales. On August 1, you will receive your customized booth application link from service@mapyourshow.com.
- 2. On your application, booth size is your anticipated size. During your scheduled appointment, you will either confirm or update this size.
- 3. Your completed booth application will be used to create the appointment schedule. Appointments are scheduled in order of priority points, highest to lowest. The appointment schedule will be published early September.
- 4. The top 100 companies (approximate) will have the opportunity to select their space via a virtual appointment September 22-30. All remaining companies can reserve their space at the Onsite Sales office at WEFTEC. The full appointment schedule will be emailed early September.

Prepare for onsite sales in New Orleans

- 1. Arrive to the Onsite Sales Office 15 minutes ahead of your designated appointment time.
- 2. Prior to your appointment, go online to www.weftec.org/2023OnsiteSales to review all Onsite Sales materials.
- 3. If you are unable to make your appointment in-person, WEF will use your completed booth application to select a booth on your behalf.
- 4. You will receive an email confirmation with your booth number assigned once complete. You will be required to provide an updated digital signature acknowledging your booth assignment.

Booth Rates and Payment Deadlines

Onsite (Advance) Sales space rates for 2023

WEF Exhibitor Members	\$42.00/sq ft plus \$250 per corner
Non-members	\$49.50/sq ft plus \$250 per corner

- Exhibitor Member is the only type of WEF Membership that receives the booth space discount. WEF Exhibitor Memberships must be active for 2023 in order to receive the member rate.
- A booth space contract will be emailed to you following your application completion August 1–26. Once you receive your booth assignment onsite, a second email with a countersigned contract and invoice will be sent to you.
- A 50% deposit is due no later than January 31, 2023.
- Full payment of the balance is due no later than May 31, 2023.

Exhibit Space Cancellation Policy

- Exhibitors cancelling or reducing space reservations before January 31, 2023, will receive a full refund.
- Exhibitors cancelling or reducing space reservations between February 1, 2023, and May 31, 2023, are subject to liquidated damages of 50% of total booth fees of the cancelled space.
- Cancellation/reductions after May 31, 2023, are subject to liquidated damages of 100% of total booth fees.
- Per the terms of the License Agreement, cancellation requests must be received in writing to WEFTECSales@wef.org.

The following information allows WEF to prepare for your appointment, anticipating your needs. You will select the actual booth space (and size) that best fits your interests at WEFTEC Onsite Sales, October 9-12 in New Orleans.

During the booth application process, we will ask you to indicate if your company is interested in exhibiting in the General Exhibition and/or a Specialty Pavilion. You may make multiple selections.

Companies must be pre-qualified to exhibit in a specialty pavilion. Please submit supporting documentation to WEFTECSales@wef.org. If you selected a specialty pavilion you have current booth space in at WEFTEC 2022, you do not need to submit documentation.

- □ General Exhibition
- □ Specialty Pavilions
 - □ Discovery Zone

Only available to startups who are first time exhibitors and have won innovation awards or companies who are exhibiting for the first time on their own outside of the Innovation Showcase. These spaces are 8'x8' and come with a basic counter, carpet, and chairs.

□ Distributed Infrastructure Zone

For exhibitors with a focus on treatment and disposal of reuse water – rainwater, greywater, wastewater, or other alternative water supplies – in or near buildings and the property close to them. Companies exhibiting here must have at least 50% of their display focused on distributed infrastructure.

□ Drinking Water Pavilion

For exhibitors with a focus on water reuse (including potable) or drinking water treatment and/or distribution. Companies exhibiting within this pavilion must have at least 50% of their display dedicated to reuse or drinking water. Relevant programming will take place in the SDG Theater located in the Drinking Water Pavilion.

□ Innovation Zone

Booths surrounding Innovation Showcase and Theater, Discovery Zone, and Distributed Infrastructure Zone. These booths are for alumni of the pavilion or other companies who have won recent innovative product awards.

☐ Intelligent Water & Cybersecurity Pavilion

For exhibitors featuring product(s) that protect networks, devices, and data for critical infrastructure applications. The pavilion will also feature technologies to optimize system operations, promote the application of process instrumentation, control equipment and automation, and the management of information in the water environment. At least 75% of the display must be dedicated to Intelligent Water and/or cybersecurity solutions.

□ Stormwater Pavilion

For exhibitors focused on stormwater or wet weather management products – rainwater technologies, green stormwater infrastructure, stormwater control measures or BMP systems, stormwater filter systems, and more. Companies choosing to exhibit must focus 50% or more of their display on these products.

Why Are Priority Points Important?

How are Points Earned?

Exhibitors can earn points as follows:

- · 1 point per year for exhibiting at WEFTEC
- 1 point per year for being a WEF Exhibitor Member
- 1 point per show for exhibiting at WEF Specialty Conferences (Residuals and Biosolids, Collection Systems, Odors and Air Pollutants, Innovations in Process Engineering, Stormwater Summit, etc.)


