

Water Environment Federation® Technical Exhibition and Conference (WEFTEC®) Application and License for Exhibit Space, Advertising & Sponsorships

This Application and License shall become effective when it has been submitted by the exhibiting company ("Exhibitor") and accepted by the Water Environment Federation ("WEF"). The individual signing this Application and License represents and warrants that they are duly authorized to execute this binding Application and License on behalf of the Exhibitor and that the Exhibitor agrees to be bound by the terms of this Application and License along with the WEF bylaws, policies and other directives. Exhibitor agrees that upon acceptance of this Application and License by WEF, with or without its receipt of appropriate payment of the Exhibit Space Fee and/or further action by the Exhibitor, this Application and License shall become a legally binding contract; enforceable against the Exhibitor in accordance with its terms.

Exhibitor listed in this Application and License applies for contracted exhibit space ("Exhibit Space") at the 2026 Water Environment Federation Technical Exhibition and Conference (WEFTEC®) ("Event") and, if selected by Exhibitor, advertising and sponsorship in connection with the Event. WEF agrees to review Exhibitor's Application and License and to allow or to deny participation in the Event and/or advertising and sponsorship consistent with Event eligibility requirements, policies, and at the sole discretion of WEF.

As used throughout this Application and License, "Event Management" shall refer to WEF, its employees, agents, contractors, and subcontractors which assist in WEF conducting the Event.

INTRODUCTION

The annual Water Environment Federation Technical Exhibition and Conference (WEFTEC®) provides its members and public conference registrants with an educational program with an emphasis on cutting edge technological advances in the fields of water and wastewater treatment, collection systems, water quality, water reuse, and pollution control. WEFTEC is an integral part of WEF's educational offerings; products and services displayed, advertised, posted, linked, or demonstrated and, as such, any use of Exhibit Space must be related to the water quality industry and content must be presented in a manner that adheres to professional business standards and creates a context appropriate for all participants at WEFTEC. Should WEF determine, in its sole discretion, that any use of Exhibit Space, demonstration, sponsorship, and/or advertisement violates the terms set forth in this Application and License, is inappropriate, is outside the character and purpose of WEF or WEFTEC, or is not in the best interests of WEF or WEFTEC, WEF may require that the Exhibitor make changes to its use of the Exhibit Space, Exhibit Space personnel, sponsorship and/or advertisement including, but not limited to, dismantling its display, removing the inappropriate content or links, or ceasing the demonstration(s) as WEF deems to be inappropriate.

This Application and License is being granted to the Exhibitor to permit the Exhibitor to exhibit and/or advertise at WEFTEC. Failure of the Exhibitor to fully comply with all provisions of this Application and License may result in the termination of this License to participate in WEFTEC without refund. To permit the preparation of the Event in a timely manner and to create the appropriate environment for all the participants at WEFTEC, the policies, regulations, and procedures, including the schedule of certain activities, have been established by WEF. At its sole discretion, WEF reserves the right to unilaterally change, amend, or waive any of these requirements. All exhibitors are required to comply with WEF's

contracted online platform Terms of Use and may be required to agree to the terms of use of additional third-party platforms in order to take full advantage of all services and events included in WEFTEC.

EXHIBIT SPACE

If approved by WEF, the Exhibit Space shall be used solely by the Exhibitor whose name appears on this Exhibit Space Application and License. The Exhibitor will not sublet or assign any portion of same or share the Exhibit Space allotted with another Exhibitor, individual, business, or firm unless approval has been obtained in writing from WEF. If the Exhibit Space is shared, WEF may remove the Exhibitor and assess violations to Exhibitor, which may affect future participation in the Event. Exhibit Space is assigned after a completed Application and License is accepted by WEF.

By submission of the Application and License, the primary, secondary, and billing contacts consent to receive communications sent by or on the behalf of WEF regarding WEFTEC, WEF's programs and events, and as otherwise related to WEF's exempt purpose and mission.

Exhibit space is assigned according to an Exhibitor's earned priority points during Advance Sales. Space is assigned on a date-received basis during all other assignment periods. WEF reserves the right to assign, designate or change Exhibit Space locations. The Exhibitor may request to reserve space away from competitors. WEF will do its best to honor competitor requests but can never guarantee a specific distance from competitors. WEFTEC space is allocated by a priority point system and that system will override any requests. WEF reserves the right to reassign exhibit space and to modify the floor plan.

Companies who apply for exhibit space in a specialty pavilion must be pre-qualified and meet the specialty pavilions' individual display requirements. Supporting documentation must be submitted to WEFTECSales@wef.org.

All invoices due to WEF must be paid prior to the assignment or occupation of Exhibit Space or Exhibitor demonstrations. If, during the Event, the Exhibitor is in violation of this Application and License, WEF bylaws, policies and other directives, WEF has, at any time, the right to regain the immediate possession of any Exhibit Space, remove Exhibitor from the Event without refund. Further, WEF reserves the right to accept or to reject this Application and License and to determine the eligibility of any company or product for inclusion in this Event.

WEF does not guarantee any specific result including, but not limited to, any specific number of leads, sales, visit, views, or any form of interaction with the exhibit as a result of this License, exhibiting at WEFTEC. A lack of engagement with an exhibitor's exhibit will not be grounds for any form of refund or compensation.

BOOTH SHARES

Exhibitor may request one or more Booth Shares if an Exhibit Space of 200 square feet or larger is contracted. The primary contracted exhibitor must hold enough space to allow each company at least 100 square feet. Exhibit Space Shares must be approved by the primary contracted exhibitor. Exhibit Booth Shares may be requested by submitting a Booth Share application. Booth Shares must be paid in full before being processed and are non-refundable. Exhibit Space Shares will only be approved by WEF if the companies submitted are legally related to the primary exhibiting company and must have a parent, sibling, or child relationship to the primary exhibitor. The primary exhibiting company receives all exhibitor registrations for the Exhibit Space. Exhibit Space share companies do not receive their own exhibitor registration allotment.

Only primary exhibiting companies are awarded priority points for their exhibiting participation. Booth share companies are not awarded priority points for their exhibiting participation.

PRIORITY POINT POLICY

WEFTEC exhibit space is assigned according to an exhibitor's earned priority points during advance sales and considered when reviewing Exhibit Space move requests. During general sales, contracts received are assigned on a date-received basis.

Priority points can be earned as follows:

- 1 point per year for exhibiting at WEFTEC.
- 1 point per year for holding active WEF Exhibitor Membership.
- 1 point per show for exhibiting at WEF Specialty Conferences.
- 1 point per show for exhibiting in WEF's International Pavilion program. (1 additional point for signing up by October 31)
- 1 point for the winner of the WEFTEC Sustainable Booth Award (one award per year)

Exhibitors may lose 1 point per infraction for failure to adhere to show policy such as exhibitor display out of compliance with show regulations. Exhibitors will lose 5 points per infraction for early tear-down or abandonment.

All accrued points will be removed from an exhibitor's record if the exhibitor misses two consecutive WEFTEC shows.

Mergers and Acquisitions: When a WEFTEC exhibiting company is part of a merger or acquisition, the acquired company may transfer its higher priority points to the acquiring company. To do so, legal documentation must be presented to WEF that shows all assets were sold to the acquiring company, including Exhibit Space points. Once received, WEF can transfer the points to the acquiring company. The new points will supersede the acquiring company's existing points, if any. Points cannot be combined.

EXHIBIT SPACE FLOOR LAYOUT & DESIGN

WEF reserves the right to assign, designate or change Exhibit Space locations. The aisles belong to WEF unless otherwise noted. Neither exhibits nor advertising material will be permitted to protrude into the aisles. End cap Exhibit Space is not permitted as the back wall blocks the line of sight to other in-line Exhibit Spaces in the same aisle. WEF reserves the right to control and prohibit any disruptive noises produced by an Exhibitor. Any unfinished portion of an Exhibit Space must be draped at the expense of the Exhibitor. Carpet and/or alternative floor covering is required in all Exhibit Spaces. The carpet or floor covering must fill the entire dimensions of the Exhibit Space. Carpet will be installed by WEF, at the Exhibitor's expense, if the Exhibit Space is without carpeting and/or alternate floor covering on or before 6:00 p.m. CT, Sunday, September 27, 2026.

LOCAL LAWS

Exhibitor shall comply with all applicable laws and regulations including, but not limited to, those relating to health and safety, as well as WEF directives relative to number of persons in their Exhibitor Space, social distancing, face coverings, and any other directives issued by WEF to Exhibitor.

PAYMENT

Assignment of Exhibit Space is contingent upon WEF's acceptance of this Application and License and its receipt of payment from Exhibitor in accordance with the payment schedule set forth below.

<u>Advance Sales:</u> For Exhibitors which have been notified by WEF that they are eligible for Advance Sales and reserve Exhibit Space on or before October 1, 2025, payment due as follows:

January 31, 2026: 50% Exhibit Space Fee & 100% Booth Add-on Fees Due

April 30, 2026: Final Payment Due

<u>General Sales</u>: For other Exhibitors which are not designated by WEF for Advance Sales, or Exhibitors designated by WEF for Advance Sales but do not reserve Exhibit Space on or before October 1, 2025, payment due as follows:

After October 1, 2025: 50% Exhibit Space Fee & 100% Booth Add-on Fees Due

April 30, 2026: Final payment Due

Once final payment is received, Exhibit Space will be confirmed. If final payment for any Exhibit Space is not received by WEF by April 30, 2026, WEF has the right to immediately release the selected Exhibit Space and to retain all payments made to it by the Exhibitor. Exhibitors which paid fees by credit card may not challenge cancellation fees charged to such credit card for cancellation fees as set forth in this provision.

EXHIBITOR MEMBERSHIP

Exhibitor is eligible for the Exhibitor Member Rate if Exhibitor has a paid WEF Exhibitor Membership at the time of billing and continuously through the last date of the Event.

Exhibitor Membership is valid for the calendar year and expires on December 31 each year. For Advance Sales, if 2026 Exhibitor Membership is not renewed or activated by January 31, 2026, the Exhibit Space Fee will be changed to the non-member rate and the Exhibitor is responsible to pay the full Exhibit Space Fee at the non-member rate.

For the General Sales period, applicants who request the Exhibitor Member Exhibit Space rate, whether current 2025 Exhibitor Members or new, must have an active (paid) 2026 Exhibitor Membership to be assigned at the Exhibitor Member rate. Exhibit Space applications requesting the Exhibitor Member Exhibit Space rate will not be assigned until the 2026 Exhibitor Membership is renewed/activated.

Active Exhibitor membership must be maintained to retain the exhibitor member rate.

BOOTH MOVES

Booth moves will begin in November 2025 and end August 2026. The Booth Move Request form allows contracted exhibitors to relocate and/or adjust their current space. Companies must be in good financial standing with WEF and must be up to date on their booth deposits in coordination with the payment schedule. The cancellation policy, which includes booth space reductions, is detailed below.

Lateral moves are permitted through May 31, 2026. After May 31, 2026, booth moves are permitted only for upgrades or because of a requested downgrade.

Booth Move Request Process & Communication

Booth move offers are determined by date received and upgrades receive precedence. Priority
points and membership status will be used as a tie breaker. WEF will only reach out if a booth
move offer is available. WEF is unable to provide a timeline on your request as the waitlist

process is only activated when booths become available through booth moves or cancellations. WEFTEC Exhibition Sales will contact you directly if a booth becomes available to you on the waitlist. Once the offer is sent, you will have a limited time to accept the booth move before it is offered to the next exhibitor on the waitlist.

- We strongly suggest you designate a Secondary Contact so the booth move option can be sent to multiple contacts when available. Update your contact preferences in the WEFTEC 2026 Exhibitor Resource Center under Company Information & Contacts.
- Communications will come from service@mapyourshow.com and WEFTECSales@wef.org.
 Please add both email addresses to your safe senders list.
- This policy is subject to change pending WEFTEC exhibit space availability. All matters and
 questions not specifically covered by the policy are subject to the decision of Event
 Management and those decisions will be final.

CANCELLATION AND NO-SHOW POLICY

All Exhibit Space deposits and payments become the sole property of WEF and their return is subject to the cancellation and refund provisions as follows:

- Exhibitor shall provide WEF with a written notice of the Exhibit Space cancellation. Cancellations are
 not effective until received by WEF in writing. Written cancellations may be sent by e-mail to
 WEFTECSales@wef.org.
- Exhibitors which provide a written cancellation on or before January 31, 2026, will receive a full refund.
- Exhibitors which provide a written cancellation between February 1, 2026, and April 30, 2026, will be liable for a cancellation fee equal to 50% of the Exhibit Space Fee; any fees paid that exceed the amount of the cancellation fee due will be refunded.
- Exhibitors which provide a written cancellation after May 1, 2026, but prior to 12:00 pm CT,
 September 27, 2026, will be liable for a cancellation fee equal to 100% of the total contracted
 Exhibit Space Fee.
- Exhibitors which do not claim their Exhibit Space by 6:00 pm CT on Sunday, September 27, 2026, or for which WEF has not approved special arrangements for claim of their Exhibit Space, will be considered a "no-show" and are liable for a cancellation fee in the amount of 100% of the Exhibit Space Fee. The Exhibitor will be deemed to have cancelled and must forfeit their Booth Personnel Registration Badges, rights to the attendee list and all exhibiting benefits; and must exit the Exhibition and WEFTEC immediately. WEF reserves the right to determine sanctions imposed on Exhibitor as a result of a no-show including, but not limited to, the prohibition of Exhibitor at any future WEF event.
- If Exhibitor reduces the Exhibit Space reserved, a cancellation fee will apply to the portion of the
 Exhibit Space cancelled. WEF cannot guarantee the originally assigned Exhibit Space if Exhibitor
 reduces the originally reserved Exhibit Space and reserves the right to reassign the Exhibit Space as
 necessary to maintain the integrity of the floor plan.
- If Exhibitor increases its Exhibit Space and then subsequently cancels its participation in the Event, a cancellation fee shall be assessed based on the increased Exhibit Space Fee.
- If, due to a merger and/or acquisition involving Exhibitor, such Exhibitor seeks to retain its Exhibit
 Space and/or cancels its participation in the Event or reduces the size of its Exhibit Space, any
 Exhibit Space or cancellation fees will be the responsibility of Exhibitor based on the cancellation
 policy above.

INDEMNIFICATION AND INSURANCE

Exhibitor agrees to indemnify, defend and hold the Water Environment Federation, its directors, officers, agents, representatives and employees, and each of them, Ernest N. Morial - New Orleans Exhibition Hall Authority; New Orleans Public Facility Management, Inc. (NOPFMI), and the President/General Manager of NOPFMI, or his authorized representative, other Event vendors, and their respective facilities, agents, trustees, officers, board members and employees harmless against all claims, losses, damages, liabilities, costs, and expenses (including attorneys' fees), damages to persons or property and governmental charges or fines arising out of or caused by: (i) the installation, removal, maintenance, occupancy or use of the Event premises or any part thereof; (ii) the performance or the breach of any term of this Application and License, applicable laws and regulations, policies, or directives of WEF; or (iii) the negligence, gross negligence or willful misconduct of Exhibitor, its employees, agents or contractors. The terms of this provision shall survive the termination or expiration of this Application and License.

Exhibitor must maintain Worker's compensation and employer's liability insurance in full compliance of all Federal and State laws covering all employees and Independent Contractors.

The Exhibitor must maintain and provide proof of insurance issued by an insurance company duly authorized to conduct business in the State of Illinois and with an A.M. Best rating of A:VIII or better. *Insurance policies issued outside of the United States cannot be accepted.* Comprehensive General Liability or Commercial General Liability and Automobile Insurance must name the following Additional Insureds: Water Environment Federation, Ernest N. Morial - New Orleans Exhibition Hall Authority; New Orleans Public Facility Management, Inc., and the President/General Manager of NOPFMI, or his authorized representative, and their facilities, agents, trustees, officers, board members and employees.

- Comprehensive General Liability (Broad Form) or Commercial General Liability with limit of liability for bodily injury and property damage of not less than \$1,000,000.00 per occurrence
- Comprehensive Automobile Insurance covering any owned, not owned/hired and hired selfpropelled vehicles of the type for use on and off Ernest N. Morial - New Orleans Exhibition Hall.
 Coverage should include loading and unloading hazards
 - o \$1,000,000 for property damage for each occurrence
 - o \$1,000,000 for all injuries and/or deaths resulting from any one occurrence
- Fire Legal Liability in the amount of \$100,000.00

Ø Additional insurance protecting exhibitor's assets and property brought to the exhibit is recommended.

Proof of insurance must be provided. Failure to provide required proof of insurance may incur sanctions imposed on Exhibitor including, but not limited to, forfeiture of Exhibit Space at the Event without refund or prohibition of Exhibitor at any future WEF event.

DRONES

Drone operators must provide a current FAA Remote Airman Certificate, Certification of Insurance for General Liability coverage that specifically states coverage for drone exposures, Drone or Unmanned Ariel System (UAS) specifications (brand, model, dimensions, weight), and a description of intended use.

Additionally, prior to operating a drone or UAS on or over NOPFMI property, the Operator must furnish show management and NOPFMI with proof of insurance as follows: Evidence of General Liability coverage in the form of a Certificate of Insurance (COI) with minimum limits of \$1,000,000 per occurrence shall be provided. Such coverage shall name and evidence the City of New

Orleans, New Orleans Public Facility Management, Inc., and Ernest N. Morial – New Orleans Exhibition Hall Authority as Additional Insureds for both on-going and completed operations. Further, the evidence of coverage shall contain a Waiver of Subrogation in favor of the Additional Insureds. The COI shall specifically confirm coverage for the drone exposure in the description section of the document.

SECURITY

WEF shall provide security for the Exhibit Hall from September 21, 2026, to October 2, 2026, but WEF does not guarantee, nor insure the Exhibitor against loss of any kind for its Exhibit Space by any reason thereof. WEF, the official service contractor, Ernest N. Morial - New Orleans Exhibition Hall Authority, New Orleans Public Facility Management, Inc. and Ernest N. Morial Convention Center – New Orleans do not maintain insurance covering an Exhibitor's property. It is the sole responsibility of the Exhibitor to obtain the appropriate amount and type of insurance to cover its property, agents or employees from theft, damage by fire, accident or any other cause. WEF will not be responsible for any injury that may occur at Event and/or any Exhibit Space, and/or to Exhibitor's employees, contractors, or agents, or for the loss of, or damage to, any material from any cause whatsoever, whether in transit to or from, and/or during the Event, regardless of whether WEF furnishes attendants, guards or night watchpersons.

CANCELLATION OR MODIFICATION OF THE EVENT; FORCE MAJEURE

Exhibitor acknowledges and agrees WEF may cancel, delay, shorten, modify in format the Event for any reason including those beyond its control including, but not limited to, acts of God, shortage of commodities or supplies to be furnished by the facility, infectious or communicable diseases, governmental authority, terrorism, threats of terrorism, or war in the United States. Exhibitor understands and agrees that all losses and damages which it may suffer as a consequence thereof are its responsibility and not that of WEF, its trustees, officers, employees or agents. Exhibitor understands that it will lose all monies it has paid to WEF for Exhibit Space in the Event (no refunds will be given), as well as other costs and expenses it has incurred including, but not limited to, travel to the Event, setup, lodging, freight, banners, décor, and employee wages.

Exhibitor agrees to indemnify, defend, and hold harmless WEF, its officers, trustees, employees, agents, and each of them, from any and all loss which Exhibitor may suffer as a result of the cancellation of or changes to the Event. Further, Exhibitor releases WEF, its trustees, officers and employees and/or agents from any and all claims including, but not limited to, lost profits, out-of-pocket costs, and indirect and/or consequential damages. The terms of this provision shall survive the termination or expiration of the Application and License.

ACCESS TO PERSONAL DATA

In connection with its participation in the Event, Exhibitor may have access to the personal data of members of WEF or participants in the Event. Exhibitor agrees that it shall be solely responsible for compliance with any applicable data protection laws and regulations in connection with such data including, but not limited to, the California Consumer Privacy Act ("CCPA") and the European Union's General Data Protection Regulations ("GDPR").

EXHIBITOR ACTIVITIES

Exhibitors are prohibited from displays or demonstration items outside the Exhibit Space or scheduling of private functions, cocktail parties, special events, etc., during the listed Event hours, Monday, September 28– Wednesday, September 30, 2026. Neither hired models nor Exhibit Space personnel may walk the aisles of the Event representing or promoting a company product. No canvassing, advertising,

displaying, demonstrating, or distributing items and/or literature will be permitted outside the Exhibitor's Exhibit Space without written permission of WEF. No materials or signs shall be posted, nailed, or tacked to drapes or walls of hotel hallways or the Event area. No printed material will be allowed to be delivered to or placed under hotel guestroom doors without WEF's consent.

ADEQUATE EXHIBIT SPACE

All exhibitors must adhere to WEF's Display Guidelines and rent adequate Exhibit Space to accommodate their planned product display and shall arrange the displays to utilize only the Exhibit Space area contracted for, to recognize the rights of other exhibitors and exhibition visitors, and to conform to the overall pattern developed by Event. No exhibit may interfere with the persuse of other exhibits, impede access to other exhibits, or impede the free use of the aisles between exhibits.

EXHIBITOR'S RESPONSIBILITY

Exhibit Space must be staffed at all times during the regular Event. An Exhibitor of the Event and its affiliated agents or employees may not enter another Exhibitor's Exhibit Space without the latter Exhibitor's permission. Exhibitors shall abide by and observe all laws, rules, and regulations of the federal, state and city governments, as well as the convention and trade show facilities. This includes regulations regarding labor jurisdictions. All decorations and electrical wiring and fixtures must comply with local fire laws; state and local fire regulations must be followed.

CHARACTER AND CONDUCT

The use of any method(s) to gain an advantage over a competitor, including but not limited to the use of such competitor's tools or products, is strictly prohibited. Any Exhibit Space personnel or Exhibitor activities which WEF deems to be outside the character and purpose of WEF shall be subject to immediate termination of its Exhibit Space without any refund for the Exhibit Space and may also be prohibited from participating in future WEF events.

EVENT CODE OF CONDUCT

As a condition to participating in the Event, each individual whether as an attendee, exhibitor, exhibit space personnel, sponsor, speaker, WEF member or non-member, vendor, or other capacity (each "Event Participant") accepts and agrees to abide by the terms of the <u>WEFTEC Event Code of Conduct</u> as it may be amended by WEF along with any other terms and conditions relating to Event participation.

Any Event Participant who overhears, witnesses or experiences a violation of the Event Code of Conduct during the Event should contact a WEF team member. If you cannot find a WEF team member or would like to report a violation after the Event, you may email WEFTECSales@wef.org. Please remember that notifying WEF staff or security does not constitute or replace notification to local law enforcement.

Event Participants acknowledge that any violation of the Event Code of Conduct may result in WEF issuing them a warning, removing them from the Event without notice or refund and restricting them from attending future WEF events.

EXHIBITOR PERSONNEL AND REPRESENTATIVES

Exhibit Space must always be attended and maintained by at least one exhibitor or exhibitor representative during all exhibit hours. All representatives of the exhibitor must be registered and receive an Exhibitor badge to be admitted to the exhibit hall and participate in the exhibitor's Exhibit Space. Expo Only badges are not permitted to be used for Exhibit Space staff.

Exhibitor representatives agree to follow any and all health and safety measures as may be established and communicated by WEF, Ernest N. Morial Convention Center – New Orleans, and the city of New Orleans while attending official WEFTEC events or on transportation provided by WEF for the purposes of traveling to or from WEFTEC, and on the premises of Ernest N. Morial Convention Center – New Orleans. Failure to abide by any such health and safety measures may result in expulsion from the Event, termination of this Application and License and loss of all rights granted to Exhibitor herein without refund.

EXHIBIT SPACE ACCESSIBILITY

Exhibitors shall be responsible for compliance with the Americans with Disabilities Act of 1992 with regards to their Exhibit Space, including, but not limited to wheelchair access and alternate formats of collateral materials. Further information regarding ADA compliance is available at www.usdoj.gov/crt/ada/infoline.htm.

PRESENTATIONS, SOUND & LIGHTING

Sound presentations, slides or movies will be permitted if tuned to conversational levels that do not interfere with other exhibitor activities. Exhibits may not use sound or lighting effects which interfere with other exhibits. Flashing and strobe-light effects are prohibited. WEF reserves the right to closely monitor sound and lighting usage and, where necessary, restrict demonstrations in an Exhibitor's Exhibit Space at its discretion. WEF's actions can include, but are not limited to, reviewing and adjusting all sound system and loud-speaker placements within an Exhibit Space, restricting sound levels within an Exhibit Space, and restricting demonstrations within an Exhibit Space regardless of an Exhibitor's arrangements with contracted entities appearing in an Exhibitor's Exhibit Space.

EXHIBITOR DISPLAYS AND PRODUCT DEMONSTRATIONS

Exhibitor warrants that it has all necessary rights and licenses to all content displayed in the Exhibit Space. The terms of this provision shall survive the termination or expiration of this Application and License.

HANGING SIGNS

Only booths 600 square feet or larger are permitted to have a hanging sign. Sign height is restricted to a maximum height of 20 feet at the top of the sign. Hanging signs and graphics must be rigged directly over contracted Exhibit Space and may not encroach into aisle space.

SELLING IN THE EXHIBITION

The on-site sale and/or delivery of goods is not permitted. Any violation of this requirement will result in the termination of this Application and License without refund.

GIVEAWAYS, CONTESTS, DRAWINGS

Federal, state, and local laws heavily regulate drawings, lotteries, and/or contests that have prize giveaways. The laws of each state and location vary widely. The WEF Trademarks shall be used only by the Exhibitor and for the sole purpose of indicating to the public that Exhibitor will be present and exhibiting at the Event. The WEF Trademarks shall be used in print, online, email, and exhibit display materials only prior to and during the Event itself. This Application and License shall terminate automatically at the close of the Event. WEF Trademarks appearing in pictures and/or video recordings of an Exhibitor's demonstrations or Exhibit Space created during the Event may be used and shown after the Event provided the picture(s) and/or video are used primarily to show Exhibitor's Exhibit Space and do not prominently feature or focus on the WEF Trademarks.
